INSTRUCTIONS FOR THE CANDIDATES WHO HAVE REGISTERED FOR ADMISSION TO PANJAB UNIVERSITY B.A.LL.B./B.COM.LL.B. (HONS.) COURSE-2020 AND HAVING PASSED 10+2 EXAMINATION WITH ATLEAST 50% MARKS (45% MARKS IN CASE OF SC/ST/BC/PwD).

Important Notes:

- Considering the COVID-19 situation, the Panjab University has scrapped the UGLAW entrance test and the admission will be based on 10+2 examination result.
- The candidates who have registered themselves at UGLAW website for admission to PU B.A.LL.B. (Hons.) / B.COM.LL.B. (Hons.) session - 2020 and have passed 10+2 examination are eligible for admission to both the courses for the session 2020.
- The Online Admission form will be available from **24th September, 2020** for admission to the said course/s at website <http://uglaw.puchd.ac.in>. All the registered candidates need to fill the Admission Form.
- The candidate who already applied and completed the admission forms, need not to apply again. They will be able to check their forms from **24th September, 2020**.
- The Candidate who were not able to complete the admission forms before termination of process due to Hon'ble Court's directions, can complete the forms from **24th September, 2020**.
- Last date for filling up of online Admission form **1st October 2020**.
- Once the candidate has submitted the online Admission Form, any change at any stage in the Form **including the category once marked shall not be allowed**.

1. **Before filling up the online Admission Form, read the instructions given below carefully:**
 - Complete each section (**Categories, Class +2 subjects, Weightages and upload Documents**) carefully and lock each section. (**Once you lock the section, you will not be allowed to change information in that section and the information presumed to be final**).
 - **The responsibility for any false information, uploading of documents, mentioning of wrong marks or any kind of misrepresentation shall be solely of the candidate. It shall lead to cancellation of candidature and further legal action may also be initiated.**
2. The candidates applying under **SPORTS CATEGORY** need to send hard copy of the Admission Form complete in all respects along with *Undertaking of Sports achievements* through registered post/speed post to the **Directorate of Sports, Panjab University, Sector – 14, Chandigarh – 160014 up to 06.10.2020.** The Institute will not take any responsibility for Non submission of Admission Form at Sports Department of Panjab University.
3. Guidelines for **ADMISSION TO RESERVE CATEGORY OF SPORTS** (these guidelines are available at pages 51 – 60 in the Prospectus – 2020 available at Website uglaw.puchd.ac.in).
4. The admission under reserve category of sports for the session 2020-2021 only be made on the basis of gradation of **Sports Certificates and other required documents.**
5. **NRI CATEGORY:**

The candidates seeking admission under **NRI CATEGORY** need to submit soft copy as well as **hard copy of Admission Form along with copies of relevant certificates.**

 - a) The candidates seeking admission under **NRI CATEGORY** and have registered for UGLAW entrance test, need to select NRI

category while filling up online admission form that will be available at website uglaw.puchd.ac.in on **24.09.2020**. These candidates also need to take print out of filled up admission and email it along with scanned copies of all other required documents to uils_pu@pu.ac.in upto **03.10.2020**.

- b) The candidates seeking admission under **NRI CATEGORY** and have not registered for UGLAW entrance test, need to take print out of admission form available separately. After completing this form and email it along with scanned copies of all other required documents to uils_pu@pu.ac.in upto **06.10.2020**.
- c) All the candidates seeking admission under **NRI CATEGORY** need to send **hard copy of Admission Form along with copies of relevant certificates** through registered post/speed post to **Director, University Institute of Legal Studies, Panjab University, Sector -14, Chandigarh-160014 upto 06.10.2020**
6. Tentative Merit List will be displayed on the <http://uglaw.puchd.ac.in> website by **19th October, 2020 (evening)** for seeking objections, *if any*. **(The merit list of Sports Category will be published subject to the Grading provided by Directorate of Sports, Panjab University)**
7. Objections, regarding the Tentative Merit List, *if any*, should be reported by **20th to 21st October, 2020 (midnight)** positively on e-mail address (uglaw@pu.ac.in).
8. Provisional Merit List for all categories after entertaining the objections raised, if any, shall be displayed on **23rd October, 2020 by evening (The merit list of Sports Category will be published subject to the Grading provided by Directorate of Sports, Panjab University)**
