MARKS (45% MARKS IN CASE OF SC/ST/BC/PwD).

- The candidates who have qualified PU- B.A./B.Com.LL.B. (Hons.) 5 Years Integrated Course **Entrance Test-2022** and have passed 10+2 examination are eligible for admission to both the courses for the session 2022.
- The Online Admission form will be available from **5th August, 2022 (evening)** for admission to the said course/s at website <http://uglaw.puchd.ac.in>.
- The candidates can fill up Admission Form by login at <http://uglaw.puchd.ac.in>.
- Last date for filling up of online Admission form **14th August 2022**.
- **Last date for submission of hard/printed copy of Admission Form and relevant documents by hand or by post in the office of the Admission Co-ordinator, University Institute of Legal Studies, Panjab University, Sector – 14, Chandigarh-160014 is 16th August 2022 (till 4:00 p.m.)**.

 - **The responsibility for any false information, uploading of documents, mentioning of wrong marks or any kind of misrepresentation shall be solely of the candidate. It shall lead to cancellation of candidature and further legal action may also be initiated.**
2. Submit the signed copy of Admission Form complete in all respects either by hand or by registered/speed post in the office of **Director University Institute of Legal Studies, Panjab University, Chandigarh**. latest by **16th August, 2022 till 4:00 p.m.**
