INSTRUCTIONS FOR THE CANDIDATES WHO HAVE QUALIFIED PU-B.A./B.COM.LL.B. (HONS.) 5 YEARS INTEGRATED COURSE ENTRANCE TEST-2026 AND HAVING PASSED 10+2 EXAMINATION WITH ATLEAST 50% MARKS (45% MARKS IN CASE OF SC/ST/BC/PWD).

**Important Notes:**

- The candidates who have qualified PU- B.A./B.Com.LL.B. (Hons.) 5 Years Integrated Course **Entrance Test-2026** and have passed 10+2 examination are eligible for admission to both the courses for the session 2026.
- The **Online Admission Form** will be available from **20th May, 2026 (evening)** for admission to the said course/s at website <http://uglaw.puchd.ac.in>.
- The candidates can fill up Admission Form by login at <http://uglaw.puchd.ac.in>.
- Last date for filling up of online Admission form **14<sup>th</sup> June 2026**.
- Last date for submission of hard/printed copy of Admission Form and relevant documents by hand or by post in the **office of the Director, University Institute of Legal Studies, Panjab University, Sector – 14, Chandigarh-160014** is **17<sup>th</sup> June 2026 (till 4:00 p.m.)**.
- Once the candidate has **saved/locked** the online Admission Form, any change at any stage in the Form **including the change in category once marked shall not be allowed**.
- On the successful submission of online admission form, a **DIARY Number** will be generated in their account at [uglaw.puchd.ac.in](http://uglaw.puchd.ac.in)
- After submission of admission form, **VERIFICATION STATUS** will be showing pending. That will be updated 2 or 3 days prior to preparation of tentative merit list.

1. **Before filling up the online Admission Form, read the instructions given below carefully:**
  - Complete each section (**Categories, Class +2 subjects, Weightages and upload Documents**) carefully and lock each section. (Once you lock the section, you will not be allowed to change information in that section and the information presumed to be final).
  - The responsibility for any false information, uploading of documents, mentioning of wrong marks or any kind of misrepresentation shall be solely of the candidate. It shall lead to cancellation of candidature and further legal action may also be initiated.
2. Submit the signed copy of Admission Form complete in all respects either by hand or by registered/speed post in the office of **Director University Institute of Legal Studies, Panjab University, Chandigarh**. latest by **17<sup>th</sup> June, 2026 till 4:00 p.m.**
3. **SPORTS CATEGORY:** The candidates seeking admission under reserved category of **Sports** also required to submit **one set** of Admission Form & copies of relevant certificates by hand or through registered post/speed post to **Directorate of Sports, Panjab University, Sector 14, Chandigarh – 160014 up to 17<sup>th</sup> June, 2026 till 4:00 p.m.** The Institute will not take any responsibility for Non submission of Admission Form at **Sports Department of Panjab University. For more information check pages 53 – 63 of admission prospectus.**
4. If the candidate seeking benefit of any reserve category the certificate should be as per the prescribed format in the **Prospectus – 2026** available at Website <http://uglaw.puchd.ac.in>
5. Tentative Merit List will be displayed on the <http://uglaw.puchd.ac.in> website **by 1<sup>st</sup> July, 2026** (evening) for seeking objections, *if any*. **(The merit list of Sports and NRI Categories shall be published subject**

**to the Eligibility provided by the concerned departments of Panjab University)**

7. Provisional Merit List for all categories after entertaining the objections raised, if any, shall be displayed on **7<sup>th</sup> July, 2026** by evening.

- Incomplete admission forms and those received after prescribed schedule shall be rejected without assigning any reason. The department will not be responsible for any postal delay or wrong delivery, whatsoever.

  7. Self attested copy of Weightage Certificate (if claiming weightage under NCC, NSS, Youth Welfare and Adult Education etc.)
  8. Self attested copy of Address Proof
- **If 12<sup>th</sup> Class Certificate has not been issued by the school institute, upload copy of 12<sup>th</sup> class result downloaded from respective board's website.**
  - **If Migration / Character Certificate has not been issued by the school/last attended institute, write an application and upload it in place of the certificate.**
